RE:	City of Edina Nine Mile Creek Enhancement Stewardship Grant Application

## Background

\$200,000 was budgeted for stewardship and habitat cost share grants in 2021. Of that, \$135,447.79 was awarded in grant funds. When there are remaining grant funds following grant deadlines, cities are allowed to submit grant application outside of the normal deadlines to utilize the remaining funds. This year there was \$64,552.21 remaining in grant funds following all grant application deadlines.

## City of Edina Application Summary


The grant project would be to enhance buffer vegetation along six reaches (1, 2, 4, 5, 11, and 12) of the north branch of Nine Mile Creek. The areas were part of the Edina Streambank Stabilization Project. The city of Edina took over maintenance of this project in 2021. This cost share grant project would enhance areas beyond the minimum maintenance requirements of noxious weed control. The grant funds would be used to enhance approximately 490,000 square feet of buffer over the six reaches.


## Request






