CAC Meeting Minutes 4/3/19

Call to order

Updates

- CAC Bylaws and Code of Conduct finalized, approved, and signed by members
- Cost share grant funds not utilized go back into the general fund can be re-allocated to another project or used for another purpose
- At a future meeting, discuss cost share policies on shoreline buffers and restoration projects

Cost Share Grant Applications

Erica Sniegowski, Program and Project Manager, gave an overview of the cost share grant review process. Discussions were held on each of the 10 applicants. Recommended projects will be presented to the board for approval at the April meeting. The following projects have been recommended to the board for funding.

Jean David – Raingarden in Bloomington - \$1,960

This project is to support the creation of a residential raingarden and will support the Winchester Pond project efforts. CAC has some concerns with actual plan of raingarden. Need re-submitted design plan.

Heather Collen - Raingarden & Swale in Hopkins - \$3,500

Project entails the installation of a native plant raingarden, native plant vegetative swale, and a speed bump on the driveway to route water that would otherwise flow into the storm sewer. Some on the CAC appreciated the uniqueness of the project and its location in Hopkins.



CAC Meeting Minutes 4/3/19

Desi Creswell - Shoreline restoration in Edina - \$4,608.75

Project is for lakeshore restoration that would convert non-native plants into a native landscape, promote soil stability and aid in runoff control. Project looks great but CAC had concerns on using cost share funds for turtle log, and that item was not funded.

Joanna & Ben Accola – Raingarden & restoration in Bloomington - \$2,610

Project will convert existing front yard into a rain garden and native plant habitat. Would also aid in mitigating runoff to the wetland behind the house. CAC has some concerns on lack of final planning, requests that more formalized plan be submitted.

William & Meredith Davis - Shoreline restoration in Edina - \$3,915

Project will install native plants to create shoreline buffer.

Ron & Stephanie Rasley - Shoreline restoration and buffer in Edina - \$5,000

Project will establish shoreline buffer to aid in filtering runoff into Lake Cornelia. CAC approved the request.

Heidi & Dan Niziolek - Permeable paver driveway in Bloomington - \$0

Project requests funding to install permeable paver driveway and assist in mitigating some of the water runoff that would support the Winchester Pond Project. The CAC has concerns on this project to protect water quality and did not approve funding.

Zachary Forsyth - Native habitat restoration in Eden Prairie - \$1,800

Homeowner borders wetlands near Discovery point trail and would like to remove invasive plants on eastern half of property. Would be replaced with native plants.

David & Amanda Simons – Buckthorn removal and native plant restoration in Edina - \$0 The CAC noted concerns that this a landscaping project and did not fund.

Maria Ryan - Native habitat restoration in Minnetonka - \$4,332.16

Project would remove invasive buckthorn and restore native plant species along with a pollinator garden. Some CAC members thought the application was excellent and well thought out.
