#### 4. Project Updates

- a. <u>Holiday/Wing/Rose</u> water quality study these Minnetonka lakes have no public access and are surrounded by private properties. Study just starting. Similar process ongoing on Arrowhead and Indianhead lakes in Edina. These studies (Use Attainability Analysis or UAA) monitor water quality and help inform if projects are needed to improve water quality.
- b. Rosland Park project updates Hoping to improve water quality in Lake Cornelia by reducing phosphorous. WSB helping study goldfish populations as well. Stormwater



filtration will take place in a vault that filters water from Swimming Pool Pond. The cleaner water is pumped to lake Cornelia. Three different filter types will be tested in this filtration vault, which will be operational by next spring. More details on 9 Mile Creek website.
