Notice is hereby given that the Nine Mile Creek Watershed District Board of Managers will hold public hearings pursuant to Minnesota Statutes sections 103B.251 and 103D.341 at 5:30 p.m., on Thursday, December 7, 2023, at the NMCWD offices, 12800 Gerard Drive, Eden Prairie.

The board will receive comments on proposed amendments to the NMCWD rules applicable to road projects. The proposed revisions and a memo providing the underlying reasoning are available on the NMCWD website: www.ninemilecreek.org/rules-revision-public-comment.

The second hearing is to receive comments on proposed Holiday, Wing and Rose Lakes Water Quality Projects and consider ordering the projects. The estimated cost of the projects – alum and iron in-lake treatments on Lake Holiday and Wing Lake, an alum treatment on Rose Lake, and the installation of an in-lake aeration system and curlyleaf pondweed management on Holiday Lake – is \$575,000. The projects will be funded through a watershed-wide levy on property within the watershed.
