#### 7. Snow storage pile monitoring

- a. Volunteers needed, January to April, once per month
- b. Monitoring size and shape of piles, visually; tools and training will be provided
- c. Snow cannot be hauled off site for this research project
- d. We have a few locations and volunteers already, but can use more of each.
- e. Potential locations of snow piles include: Bredesen (Heather can monitor if this is a good site—Gael will check with city staff). Cub parking lot off France in Bloomington, potential historical photos of size?

### 8. Water Management Plan engagement

- a. Kickoff at State of the Waters, March 2025
  - i. Location for kickoff needed: places identified: 9 Mile Brewing in Bloomington, Staring Lake Pavilion, Hopkins Pavilion in Central Park, Wooden Hill Brewing Edina, Edina Lunds and Byerlys, VFW/Legions
- b. CAC input will be needed on issue identification and goal prioritization
  - i. Other staff will attend future meetings to facilitate this process more—the whole CAC group will be asked to help with this process, with at least one meeting in 2025 being dedicated to the WMP.
  - ii. Roger, Tim, and Heather volunteered to help in addition to this future meeting with the whole group.

- a. Members voted to change the name to Community Advisory Committee (both to be more inclusive of those who are not citizens, and to keep the acronym).
