Notice is hereby given that the Board of Managers of the Nine Mile Creek Watershed District will hold a public hearing pursuant to Section 103D.911 of Minnesota Statutes, on Tuesday, August 31, 2021, at 6:00 p.m., to hear comments on, and consider the District's budget and levy for the year 2022. The total proposed expenditures for 2022 are \$4,110,000. Proposed levy is as follows:

- A \$2,600,000 Metropolitan Surface Water Management Act implementation levy as authorized by Minnesota Statutes Section 103B.241.

The hearing will be held by web-based video conference, pursuant to Minnesota Statutes section 13D.021, after the NMCWD president determined that because of the COVID-19 pandemic it is not prudent for the Board of Managers to meet in person.
