**Joanna and Ben Accola, Raingarden and Native Plant Restoration (9001 Lakeview Rd, Bloomington)
\$2,610**

Install a 700 sq ft raingarden and restore 1,022 sq ft of native plant habitat.



**Heather and Anthony Collen, Raingarden and Vegetated Swale (14 19th Ave N, Hopkins)
\$3,500**

Install a 150 sq ft raingarden and 189 sq ft vegetated swale to capture water from 1,000 sq ft of impervious surface. Water is captured from roof and driveway.



Desi Creswell, Shoreline Buffer (6700 Point Dr, Edina)

\$4,608.75

Install a shoreline restoration on Lake Cornelia.



Jean David, Raingarden (10038 Drew Ci, Bloomington)

\$1,960

Install an approx. 300 sq ft curb-cut raingarden as part of the Winchester Pond Improvement Project.



William and Meredith Davis, Shoreline Buffer (6616 Cornelia Dr, Edina)

\$3,915

Install a 65' by 6' shoreline restoration on Lake Cornelia.



Zachary Forsyth, Buckthorn Removal with Habitat Restoration (6969 Edgebrook Pl, Eden Prairie)

Remove about 4,800 sq ft of buckthorn and replant with natives. Property is along Cardinal Creek trail.

\$5,000

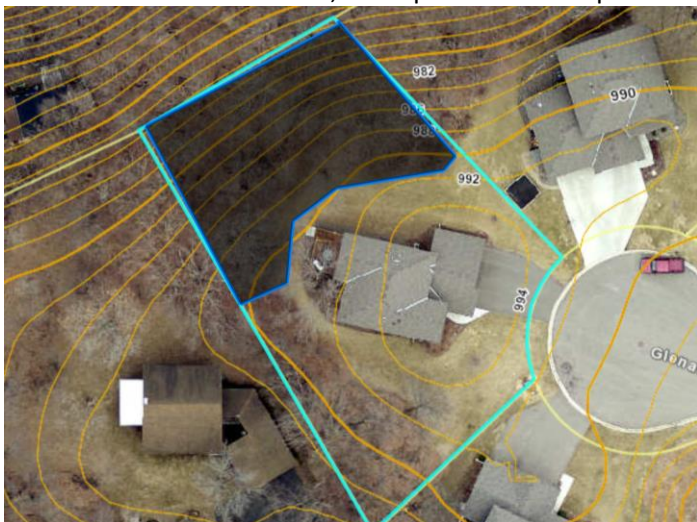
Install an 81' by 4' shoreline restoration on Lake Cornelia, along with 2 rainbarrels.



Maria and Kevin Ryan, Buckthorn Removal & Habitat Restoration (13335 Glenavon Ct, Minnetonka)

\$4,332.16

Remove buckthorn in an 8,000 sq ft area and replant with natives.



ASSOCIATION APPLICATIONS

**Girard Park West Condominium Association, Shoreline Buffer & Swale (8441 Irwin Rd, Bloomington)
\$20,000**

Install a 2,800 sq ft shoreline buffer along the pond and a 13,600 sq ft woodland and wetland edge restoration. In addition, install 100 sq ft of swale to reduce runoff into the pond.

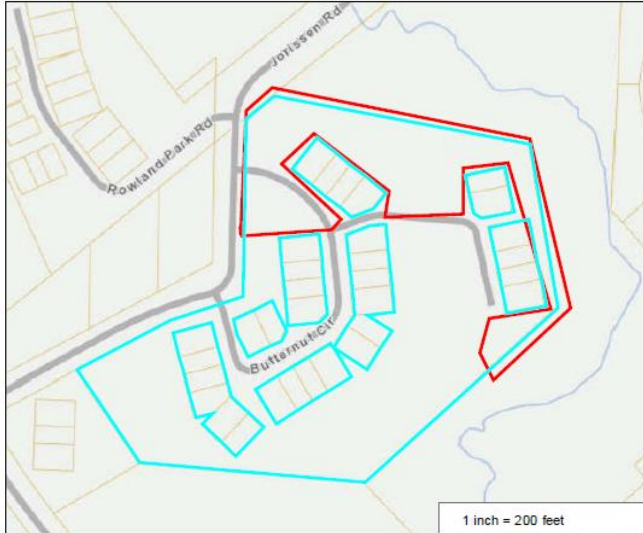
Install an approximately 250 sq ft raingarden.



Lake Forest Townhouses Association, Buckthorn Removal & Habitat Restoration (5507 Butternut Ci, Minnetonka)

\$5,760.39

Second phase in project; remove 1.4 acres of buckthorn and replant with native species.



Minnetoga Lake & Wetlands Association, 13 Raingardens (Minnetonka)

\$19,197.54

Install 12 raingardens on properties around Lake Minnetoga.

BUSINESS/CITY APPLICATIONS

Barbara and Mohsen Zadeh (Cream and Amber, LLC), Raingarden and Permeable Paver Patio (1605 Mainstreet, Hopkins)

\$11,085

Install a 119 sq ft raingarden and a 330 sq ft permeable paver patio to capture runoff.



City of Bloomington, Curb-cut Residential Raingardens and City Raingardens

\$35,800

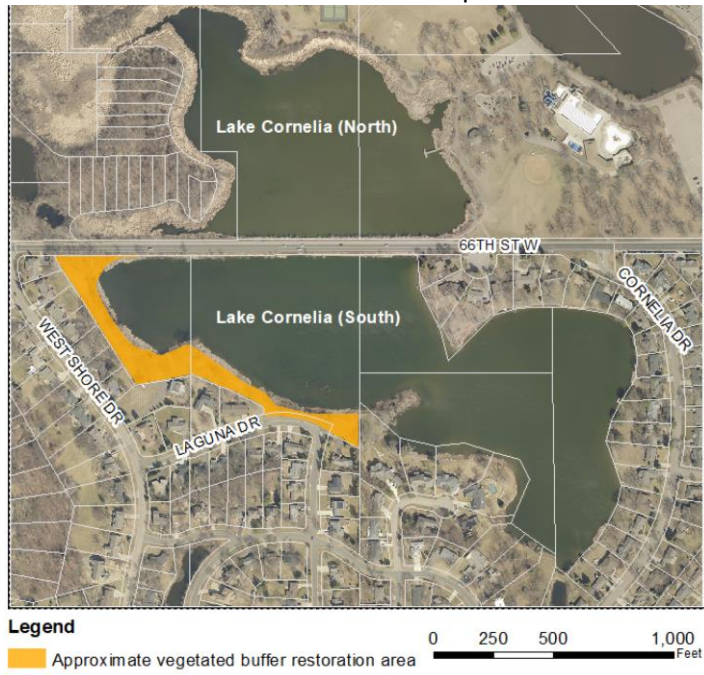
Install up to six residential curb-cut raingardens in the public right of way and four raingardens in Moir Park.



City of Edina, Shoreline Buffer (Lake Cornelia)

\$25,000

Install a shoreline buffer on a 3-acre parcel on Lake Cornelia and place it into a conservation easement.

Authorize the District Administrator to enter into cost share agreements with property owners, and provide reimbursement amounts as shown for each applicant in the table provided in this memo, which includes a 5 year maintenance agreement for residential applicants and a 10 year maintenance agreement for association, city and business applicants.
