RESOLUTION 18-09

NINE MILE CREEK WATERSHED DISTRICT BOARD OF MANAGERS

Conditionally approving City of Richfield local water management plan

Manager ______ offered the following resolution and moved its adoption, seconded by Manager _____:

- WHEREAS on October 18, 2017, in accordance with Minnesota Statutes section 103B.231, Nine Mile Creek Watershed District (NMCWD) adopted its fifth-generation Water Management Plan (WMP), which details the existing physical environment, land use and development in the watershed and establishes a plan to manage water resources and improve water quality, prevent flooding and otherwise achieve the purposes of Minnesota Statutes chapters 103B and 103D;
- WHEREAS the WMP incorporates the rules adopted by the NMCWD under Minnesota Statutes section 103D.341 to improve water quality, protect high-quality water resources, prevent flooding and otherwise achieve the goals of Minnesota Statutes chapters 103B and 103D;
- WHEREAS on June 18, 2018, the City of Richfield submitted its draft local water management plan – titled Richfield Local Surface Water Management Plan (Richfield Plan) – for NMCWD review and approval pursuant Minnesota Statutes section 103B.235, subdivision 3;
- WHEREAS section 103B.235 requires NMCWD to consider the comments of the Metropolitan Council on the draft Richfield Plan, and NMCWD has received and duly considered Met Council's August 1, 2018, comments in reviewing the Richfield Plan;
- WHEREAS NMCWD has determined that the Richfield Plan must be revised as outlined and specified in the March 12, 2018 memo attached to and incorporated into this resolution (the Memo), to meet the requirements for approval set forth in the Minnesota Rules 8410 and the WMP; and
- WHEREAS the Richfield Plan articulates the City of Richfield's decision to continue to defer exercise of regulatory authority over the use and development of land within the territorial limits of the City of Richfield within NMCWD's jurisdiction pursuant to Minnesota Statutes section 103B.211, subdivision 1(a)(3)(iii).

NOW THEREFORE BE IT RESOLVED that the Board of Managers of the Nine Mile Creek Watershed District hereby approves the Richfield Plan conditioned on Richfield's consideration of changes to and revision of the Richfield Plan in accordance with findings and comments in the Memo, and provision of a copy of the Richfield Plan as revised to NMCWD, along with a record documenting consideration of comments in the Memo not requiring revision of the Richfield Plan and the city's determination thereon; and

BE IT FURTHER RESOLVED that the Board of Managers directs the NMCWD administrator to provide such assistance, at NMCWD's sole expense, to the City of Richfield to facilitate satisfaction of the condition of approval herein.
