**RE: MN GreenCorps Host Site Application and Resolution**

### **Background**

The Minnesota GreenCorps program is a program coordinated by the Minnesota Pollution Control Agency (MPCA) that aims to preserve and protect Minnesota's environment while training a new generation of environmental professionals. The program places AmeriCorps members with host organizations around the state to assist communities and local governments in addressing a variety of statewide needs, including reducing water runoff and improving water quality.

The District is planning on applying to be a host site for a GreenCorps member starting this fall. Minnesota GreenCorps AmeriCorps members serve full-time for 11 months, from mid-September through mid-August. The District provides supervision of the GreenCorps member equating to a minimum of 3.2 hours per week and provides a dedicated workspace for the GreenCorps member. The District creates a workplan for the GreenCorps member for the 11-month duration, focusing on one of four project areas that are defined by the MPCA. A final workplan is being developed for the March 18, 2020, application deadline. The project area that we have chosen to focus on is community readiness and outreach. Other watershed districts and local organizations have hosted GreenCorps members, such as the Riley Purgatory Bluff Creek Watershed District, Capital Region Watershed District, the City of Bloomington, and Freshwater Society, among others. A resolution from the board is required for the application that supports the submission of the Greencorps host site application.
