Project Updates

Fisheries Management

Approximately 1500 carp were removed from Normandale Lake this summer. Final removal numbers will be calculated this fall/early winter as the reporting is completed. The carp removal with hoop nets that was planned for September was delayed but will still occur this fall.

Nonprofit BMP Project

MetroBlooms Design + Build will conduct its last maintenance visit of the year in October.

Discovery Point Restoration and Maintenance

MNL continues to perform maintenance activities at Discovery Point.


Arrowhead Lake/Indianhead Lake

Lake Holiday/Wing Lake/Lake Rose

The lake user survey for Lake Holiday, Wing Lake, and Lake Rose closed on October 1. Staff is working on a survey summary, which will be posted online on the project page by the beginning of December.

A community kickoff meeting for the lake study was held on September 29 at the Minnetonka Community Center. District and Barr staff and staff from the City of Minnetonka attended. Over 50 community members attended the meeting. Barr gave a presentation and small group discussions followed. Community members were asked three questions during the small group discussions: 1) What do you value most about your lake? 2) What concerns you most about your lake? 3) What is your vision for the future of your lake? All notes from the discussions are being transcribed.

The notes will be sent back to participants for review and

then finalized based on feedback. The survey results and notes from the community meeting discussions will be used to help understand existing lake conditions and issues, which will assist in the evaluation of management strategies designed to improve the health of the lakes.

Cost Share Grant Program

Grant applications for the second round of habitat restoration grants are due October 21. I met with the City of Hopkins at Valley Park on October 11 to determine the best location for the prairie and fescue demonstration garden as part of their groundwater conservation grant.
