Permit Inspection Report

Summary

This month was the first where we utilized the Permit Prioritization Protocol. The month's inspections that took place as a result of the protocol were mainly those that scored a 7 or above. It quickly became clear that because of 1) follow up inspections and 2) a need to be conscientious of resource efficiency, only about half of a month's inspections could be determined by the protocol. The remaining half would be made up of inspections that are following up on issues/complaints and sites on the inspection list that are close to those being inspected because of the protocol (and were inspected in order to be efficient with staff resources and gasoline).
