Project Updates

Normandale Lake

The drawdown is progressing at Normandale Lake. The timeline for the installation of the 36" pipe is proceeding on schedule. The fish survey at Normandale is complete, and a summary of the findings is posted on our website at: <u>ninemilecreek.org/wp-content/uploads/Normandale-Lake-2018-Fish-Survey-Summary.pdf</u>

A postcard was mailed to 2,000 households in Bloomington announcing the start of the drawdown, in addition to social media posts and a blog post on the District's website announcing the start. Discovery Point Restoration

Seeding, tree and shrub planting, and native plug planting in the phase 2 area will happen in September. The replacement trees for phase 1 will also be installed in September.

A Projects and Practices Clean Water Fund Grant application was submitted to BWSR for the installation of stormwater BMPs at six nonprofit sites in the District. The total grant request was \$199,132.99 with a match of \$49,783. Grant awards are announced in December.
