Project Updates

Normandale Lake

Carp Management

Twelve radio tags for tracking carp were ordered by Carp Solutions. Once ice is out on Normandale Lake, Carp Solutions will implant them.

Drawdown

The stop logs have been placed, and Normandale is starting to refill. The time it will take to refill will depend on weather conditions, but it should be full by the end of March. A pay app from Rachel is included for payment this month. For more details, see the Engineer's Report.

Alum Treatment

The alum treatment RFQ was sent to three companies. Quotes are due March 19th. The original RFQ was withdrawn and reissued without the tax-exempt purchasing of the alum. Staff will give an update at the board meeting.

Outreach

Two presentations on the Normandale project are upcoming. Steve Gurney (City of Bloomington) and I will give a brown bag seminar at the Normandale office towers on April 30th, and we will also present at the 2019 Water Summit on May 9th.

Nonprofit BMPs

I am working with legal counsel and Barr staff to draft a minor plan amendment to put out for public comment and on a feasibility study for the project.
