# **Project Updates**

## **Normandale Lake**

Preparation continues for the drawdown project, which will go out to bid on July 13.

The three Normandale signs have arrived and will be installed soon by the city at the lake, along with brochures about the project. The two videos about the project produced by Bloomington are available for viewing at:

The fish survey on Normandale will be conducted on July 16, 23, August 1 and 9.

## **Discovery Point Restoration**

Change Order 1 was issued for Phase 2 of the restoration to install nine 1.75" ball and burlap trees into the first phase of the restoration as replacement for trees that died. The total amount of the change order came to \$4,050. The trees will be installed later this summer/fall when the phase 2 plantings are installed. A copy of the change order is provided in the board packet. In addition, Minnesota Native Landscapes will provide the following replacement trees and shrubs for plants that were under warranty: (2) Redbud, (1) Blue Beech, (1) Hawthorn, (1) Ironwood, (1) Hackberry, (3) Hazelnut, (3) Common Ninebark

## **Education and Outreach (E/O) Program**

Staff has been coordinating with Windmill Design to update and improve elements of the website, including search and sorting functions of the resource library and improving the 'About Us" section of the website.

Nine Mile Creek wetland buffer signs were designed and ordered, along with signs for restoration cost share projects.
